Delivery Agreement..... READ & SIGN PRIOR TO UNLOADING OF THE ROLL OFF

Conditions: The Lessee agrees to indemnify and hold harmless the Lessor from any and all damages, costs, attorney fees, and/or liability of any kind resulting from the use by Lessee of said roll off. The Lessee assumes liability for damages to public or private property, hard surfaced roads, or driveways that might occur during the loading or unloading of roll off. Lessee agrees to pay Lessor for any loss or damage to said roll off due to fire, theft, or careless destruction beyond normal use. Lessor is not responsible for inclement weather conditions.

Don't put the following items in the roll off: Appliances, tires, chemicals, pesticides, paint or any other hazardous materials. Don't over-fill the roll off. Dirt, rocks, gravel, bricks, or cement can only be filled to the heavy material line on the roll off. Any items over the heavy material will need to be off-loaded, and Lessor will refuse to empty roll off until the over-loaded materials are removed. If an additional box is needed for the overloaded materials there will be an additional Haul Fee charge and Disposal Fee charge.

Payments: Lessee agrees to pay Lessor for any and all disposal costs of contents of said roll off: any and all haul fees; any and all mileage fees; and/or any and all demurrage fees. Lessee agrees to reimburse B&B Leasing Company, Inc., for all attorney's fees, court costs, and other expenses incurred by said company to enforce collection or to service their rights under this agreement, this includes a 35% collection fee that will be added to the total account charges if the services of a third party collection agency become necessary to enforce collection under this agreement. A refund is issued if the deposit is greater than the total amount due.

These conditions are effective upon delivery of said roll off.

EMPTY & RETURN AGREEMENT Read & Sign Prior to the Unloading of the Roll Off

When the driver arrives to empty the roll off: If the Lessor is not available, or if the path to the roll off is blocked, or if it can't be emptied for any reason, Lessee agrees to pay Lessor a haul fee, as agreed to below.

PULL OUT AGREEMENT Read & Sign Prior to the Unloading of the Roll Off

When the driver arrives to pull the roll off: If the path to the roll off is blocked, or it can't be pulled out for any reason, Lessee agrees to pay Lessor a haul fee, as agreed to below.

Your Deposit includes one Haul Fee charge & 2 Tons of Disposal Fee (weight charge). An invoice will be issued reflecting weight charges over 2 tons covered in the deposit.
